Her work has been mentioned in many newspaper articles, especially her involvement in calling for an environmental impact statement (EIS) as a prerequisite to the development of Discovery Park. She has regularly written "letters to the editor" and to City and District officials and she has drafted and circulated petitions on various issues."
