# **Legislative & State Service:**

- First King County woman elected to the legislature
- In 1929 she was the prime sponsor of a bill enacting corporate and individual income taxes, which passed both Houses. It would have gone on to initiative, but the State Supreme Court found it unconstitutional and struck it down.
