Personal:

- Born on a Mississippi plantation that her father managed
- Married Alvaro Shoemaker, an editorial writer for the Post-Intelligencer, in 1921 and she kept her maiden name. They had two daughters together. They divorced in 1936 but remained close friends
- Ran for prosecuting attorney in 1922, and ran for Superior Court judge in 1932 and 1934
- She set up a scholarship fund in her name at the University of Washington. "Recipients should be disadvantaged students including Native Americans, blacks, Chicanos, and foreign students.

Community Service:

- Democratic precinct committeewoman for the Magnolia district
- She made a name for herself when in 1922 Seattle police officer Charles O. Legate was shot to death in his car. The police department ruled it a suicide. The evidence seemed to prove that the case was a murder and not a suicide so she demanded a grand jury. She was able to get the ruling changed so that his widow would be awarded her husband's pension.
- Led the fight for the adoption of the child labor amendment in 1933
