Personal:

- Daughter of Ernestine and James Marston Phillips who was also an attorney, and served as Aberdeen Mayor, Washington State Legislator and later Grays Harbor Superior Court Judge
- Violinist in the University of Washington Symphony and became concert mistress
- Ran a prominent law firm in Aberdeen for over sixty years
- Married Lester "Pinky" O'Day, an insurance agent, in 1947

- University of Washington, B.A. and Law Degree
- One of six women to graduate with a law degree from the University of Washington in 1935

Community Service:

- Helped found the Grays Harbor Community Foundation in 1994, according to their website: "The Grays Harbor Community Foundation works with donors from all walks of life who want to create unique funds to improve local communities. By helping donors help their communities through charitable giving, we are working to build a community endowment for the long-term benefit of Grays Harbor County."
- The Gladys Phillips Cultural Tours Program (Bishop Tours Fund) was, according to the Grays Harbor Community Foundation website: "Established by the E.K. and Lillian F. Bishop Foundation through the vision of the late Aberdeen attorney Gladys Phillips, this fund provides opportunities for all Grays Harbor students in grades 4 and 5 to visit a cultural institution of their school's choice. OMSI, Woodland Park Zoo, Pacific Science Center, Experience Music Project, and the Washington State Historical Society are all popular choices. The fund also permits all sixth graders in Grays Harbor County to attend the Pacific Northwest Ballet's production of Tchaikovsky's Nutcracker. The Bishop Tours Fund provides money for tickets, transportation and meals."

Legislative & State Service:

• Gladys Phillips only served one term, and in a *Daily World* article she explains why: "I didn't care for the legislature. It didn't matter how much you worked. I was asked to sponsor a bill to raise the salaries of the state Supreme Court justices. The retirement benefits for judges were very, very low and salaries in those days were not that great...something like \$7,300 per year. Do you know, they voted this bill down? I had had it.

I served one term in the legislature and that was it. I didn't lay around up there. I went up there to work. I went up there for business. And the first thing that happened was a case of beer was delivered to my residence.

I got the word out. No more beer! There was all kinds of monkey business up there. You know, you're there for a purpose. I did some good things. I did some things I was proud of doing" (Spitzer, March 19, 2000)
