Ella Wintler grew up and lived, except for brief periods of her life, in Vancouver, Washington, the last of nine children in a pioneer family. Her father, John Jacob Wintler, was an immigrant from Switzerland and was employed as a harness maker. Her mother, Sarah Butler Wintler, is noted for having driven a span of mules from Carthage, Missouri to Vancouver in 1878.

She attended Central and Columbian schools and was one of twelve graduates of Vancouver High School in 1903. Wintler began her teaching career in Lake Shore School, a one-room school house teaching eight grades. She also taught at Charter Oak and Rock Creek schools. She went on to attend the University of Washington, graduating with A.B and A. M. degrees in 1910. She taught German in Mount Vernon until 1916, and then returned home to teach German, English and social studies in her former high school. She retired in 1950.

Wintler was first elected in 1938 and was known as a "staunch Republican." Although a strong Party supporter, she reflected upon retirement that, "Most legislators vote party, but I didn't. I voted the way I thought was best for the public." She considered herself a moderate: "Our Clark County in the main is a moderate county. We have a PUD. As a citizen of Clark County, I've always voted to support the PUD. Now, over in eastern Washington, if you're for anything but private power, you're practically considered a radical—around Spokane, for instance. I remember a young man from Spokane—a young upstart—introduced a bill once that would have throttled PUDs. So I voted against it. I can remember him getting so mad when it was defeated! He came back by my desk and as he passed he said, "Thanks for your vote!"

Wintler began her service in the still turbulent years of the late Depression. The IWW, called the "I Won't Works" by Miss Wintler were still active in the state and several legislators were reputed Communists. She was one of only 24 Republican members of the House in a sea of 75 Democrats. She recalled, "We Republicans were caucusing in one of the conference rooms, wondering what we were going to do. There was a knock on the door and one of the Communists came in and said they would help us elect anyone we wanted if we would join in with them. We turned him down flat!" Communist influence still held some sway in 1943 when she was given a surprise appointment to the Military Affairs Committee by Speaker Ed Reilly. "I told him I don't know much about military affairs, but I do love a parade. But I didn't think that should qualify me for that committee!" The Speaker replied that he had given her that assignment because he trusted her to vote against the Communists who were on the committee. She continued to serve on that committee for many years.

Wintler's career as an elected official followed the vicissitudes of her Party. She noted, "I used to lose against Roosevelt and then win again in off years. I ran in '48 against Truman and was defeated again. At that time we used to have a circle at the top

of the ballot to vote straight ticket. Many people, you know, feared that if they crossed to the other ticket, they'd lose their voting privilege." She lost her last race for office during the Democratic sweep against Barry Goldwater.

Still, she served ten sessions, of two years each. She was recognized for her long service by her fellow representatives in 1963 when she was elected Speaker Pro Tempore of House. Her only opportunity to preside came when the Speaker was late and she was called upon to call the session to order. She was given an inscribed gavel when she was elected, but she admitted that, "I didn't like to use the gavel."
