Excerpts taken from Piecing Together our Separate Lives:

"I was a protégé of Dan Evans, who was one of those who had persuaded me to run for the legislature in the first place. Dan always included me as a member of the leadership team. I shall be forever grateful for the education in practical politics I received in my first session, and for the respect I received form my fellow colleagues my freshman year."

"However, partisan politics is the basis of our democratic form of government. I believe wholeheartedly in the two-party system. It gives citizens a choice. There are differences in opinion and thought among the citizens of our country as to the proper role of government and on some major issues such as taxation, education and health care. These differences need to be exposed and discussed. Only when there is a strong two-party system competing for our votes are we able to have free and open discussions of these issues. This kind of repartee helps us decided whom to support and allows us to vote for the candidate who comes closest to our own personal philosophy."

"A candidate learns to adjust his or her thinking to fit more closely the philosophies of the constituency without compromising his or her basic beliefs about the role of government or personally-stated stands on certain issues. No one agrees with you 100 percent of the time."

"I do believe that I was able to demonstrate that it did not make much difference whether you are male or female in order to get a job done and get it done well. I never viewed myself as a victim of sexual discrimination, and thus I barnstormed ahead on issues of primary concern to my family and me.

I worked on issues traditionally attributed to a male, which helped me be successful in the legislature, but I was ever mindful of the women's political dilemma and spoke often of its importance. If there was a way of encouraging more women to take an active role in politics, I'd do it. I believe that only by doing so are you able to effect what is an important influence in American society – the influence of women.

I have always felt that women have a unique sensitivity that is needed in decision-making positions, and I believe that women who do reach these positions have a responsibility to help other women seek such opportunities and to get them. I have always been an activist and a mainstream politician, and have spent little time reflecting on the quality and dimension of the sexual imbalance in politics."
