• Sponsored Initiative to the people 601 in 1993. "Shall state expenditures be limited by inflation rates and population growth, and taxes exceeding the limit be subject to referendum?" It passed by 51.2% of the vote.

- Ran for U.S. Senate, position 1 in 1998. Lost to Patty Murray in the general election
- Strong supporter and fighter for campaign finance reform. Her campaigns were run with the help of grass roots supporters.
